To: Shareholders

Following the situation of the spread of COVID-19, MPG Corporation Public Company Limited ("the company") is aware of the great impact of this fatal disease. The company would like to inform you about our guidelines in holding the AGM 2020 on 29 April 2020 at 2.00 p.m. at Submanee Room, TOWN IN TOWN HOTEL, Bangkok. The Company has drawn up preventive measures to minimize risks that may arise from the contagion of COVID-19, and

the company seek cooperation from the Shareholders and Proxies as follows:

1. In the case that you transited or travelled to/from the Disease Infected Zone of the COVID-19 outbreak.

(according to the Notification of the Ministry of Public Health) and entered the Kingdom of Thailand after 14

April 2020, kindly consider to

1.1 give proxy to the designated Independent Directors instead of attending the meeting in person and in

such case please submit the Proxy to the Company in advance,

1.2 send questions in relation to the Meeting Agenda (if any) to the Company in advance.

2. The company will limit the entry-exit doors of Submanee Room, TOWN IN TOWN HOTEL Bangkok, the

Shareholders' Meeting venue.

3. The Company follows guidelines of the Department of Disease Control, the Ministry of Public Health in relation

to holding a meeting (https://ddc.moph.go.th/viralpneumonia/file/introduction/introduction16.pdf) and to

conduct temperature screening: the shareholders or the proxies whose body temperature is above 37.5

degree Celsius or who have such symptoms as coughs, sneezes and other symptoms suspicious for being

infected by COVID-19 will absolutely not be allowed to attend the Shareholders' Meeting. However, the

shareholders or the proxies whose body temperature is above 37.5 degree Celsius or who have such

symptoms as coughs, sneezes and other symptoms suspicious for being infected by COVID-19 may appoint

any one of the Company's independent directors as their proxy to attend the Shareholders' Meeting

according to 1.1 and 1.2.

comment or submit questions related to the agendas of the Annual General Meeting of Shareholders 2020 in
